## NOTIFICATION

## The 5th February 2021

No. 93—X-4/2013(P.F.)-III-R:—In exercise of the power conferred under Article 229 of the Constitution of India, the Chief Justice of the High Court of Orissa is pleased to amend "The High Court of Orissa (Appointment of Staff and Conditions of Service) Rules, 2019" as follows:—

- 1. Short Title and Commencement —These Rules may be called "The High Court of Orissa (Appointment of Staff and Conditions of Service) (Amendment) Rules, 2021" and shall come into force on the date of publication in the Official Gazette.
- The newly created post of "Diary Superintendent" shall be treated as Group-B and the
  posts of Jamadar, Duftary, Attender, Cook-cum-Caretaker and Mali-cum-Choukidar from
  SI. 45 to 49 shall be treated as Group-C.
- 3. The level of pay of the post of Treasury Sarkar shall be Level-3 in the Pay Matrix.
- 4. The post of "Diary Superintendent" shall be inserted in SI. 33-A of the Appendix-1.
- 5. The words "Senior Stenographer, Head Driver and Diary Superintendent" be substituted in place of the words "Senior Stenographer and Head Driver" occurring in 3rd line of sub-rule (1) of Rule 35 of "The High Court of Orissa (Appointment of Staff and Conditions of Service) Rules, 2019".
- 6. The categorisation, sanctioned strength, minimum qualification, experience, scale of pay and mode of recruitment of the above posts shall be reflected by way of amendment in Appendix-1 of these Rules as follows:
