In partial modification of Modified Yardstick System notified vide Notification No. 906/R dt.17.08.2020, the Hon'ble Court have been pleased to incorporate a new provision at the end of the "INSTRUCTIONS" contained in the said notification as follows:-

* Incentives for Judge Mediators

Cases disposed of through Mediation by the Judge mediator-

- Judge mediators shall be given 50% yardstick for a successful mediation and 25% yardstick for an unsuccessful mediation.
- Such percentage of yardstick shall be calculated as per the yardstick already prescribed for the contested disposal of the cases concerned.
- There shall be minimum of three sittings for an unsuccessful mediation.
- The Judge mediators have to take up mediation without hampering the court work and in accordance with the provisions of the Civil Procedure Mediation Rules, 2007.

The above modification shall come into force with effect from January, 2024.
